10. **Defibrillator:**

A big thank you to Rachel Palmer for organising the excellent training by her colleagues from Southampton Hospital in adult basic life support, paediatric life support and choking, anaphylaxis and Epipen, and defibrillator training, including having a look at and a listen to our own defibrillator. Forty five of us attended the training.

During the training it became apparent that using the defibrillator would not harm a patient even if that patient did not need it. This is because the defibrillator evaluates whether a shock is needed before delivering it. It was therefore decided to circulate to the village the code to open the cabinet.

The code is: C0147x (where 0 = zero).

It was felt it would be imprudent to display the code on the cabinet as vandals could steal it or do it damage. However, the code is inconspicuously displayed in a corner of the Parish Notice Board where strangers to the village would not know the significance of it.

During the training Rachel expressed concern that there is no lighting over the Defibrillator. It is not only dark at night but also during the day a second person is needed to shine a light onto the keypad.
